Definitions for Summary of Awards by Sponsor and Type of Activity

The category of Instruction includes the categories of sponsored instruction and academic support.

The category of Other Sponsored Activity includes the categories of other, public service and construction.

The category of Research includes research training and vessel operations.

Types of Sponsors:

Federal awards are those received directly from Federal agencies and through subawards with Federal flow-through funds.

Industry awards are those received directly from for-profit sponsors and through subawards with for-profit flow-through funds.

Non-profit awards are those received directly from non- and not-for-profit sponsors and through subawards with non-profit flow-through funds.

OSU Affiliated Foundation awards are those received directly from either the OSU Foundation or the Agricultural Research Foundation.

Private Foundation awards are those received directly from charitable foundations and through subawards with charitable foundations.

State of Oregon awards are those received from State agencies and local government entities.

Other state awards are those received directly from other state governmental entities and through subawards with other state governmental agencies.
